



CARES Act Higher Education Emergency Relief Fund HEERF II, and III Report (student) July 2021 – September 2021

(submitted to post on website by October 8, 2021)

Under the CRRSAA and ARP (a) (1) programs, student portion funds must be used to provide financial aid grants to students. The CRRSAA requires that institutions prioritize students with exceptional need, such as students who receive Pell Grants, in awarding financial aid grants to students. However, students do not need to be only Pell recipients or students who are eligible for Pell grants. In addition, the CRRSAA explicitly provides that financial aid grants to students may be provided to students exclusively enrolled in distance education.

Students cannot apply for assistance directly from the U.S. Department of Education but should contact their institutions for further information and guidance. Institutions have the responsibility of determining how grants will be distributed to students, how the amount of each student grant is calculated, and the development of any instructions or directions that are provided to students about the grant. The Certification and Agreements for the CRRSAA and ARP (a)(1) and (a)(4) funds provide that each institution applying for HEERF funds must promptly and timely provide a detailed accounting of the use and expenditure of the funds in such a manner and with frequency as required by the Secretary. Each participating institution (of HEERF) must post information on the institution's primary website, as an initial report under the CRRSAA and ARP (a) (1) and (a)(4) programs.

(1) An acknowledgement that the institution signed and returned to the Department the Certification and Agreement and the assurance that the institution has used the applicable amount of funds designated under the CRRSAA and ARP (a)(1) and (a)(4) programs to provide Emergency Financial Aid Grants to Students.

"Palo Alto College signed and returned the Certification and Agreement to the U.S. Department of Education on June 18, 2020 and intends to use no less than 50 percent of the funds received under Section 18004(a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students."

(6) The methods used by the institution to determine which students receive Emergency Financial Aid Grants and how much they would receive under the CRRSSA and ARP (a)(1) and (a)(4) programs.





Unlike the CARES Act, the CRRSAA requires that institutions prioritize student with exceptional need, such as students who receive Pell Grants, in awarding financial aid grants to students. However, students do not need to be only Pell recipients or students who are eligible for Pell grants. In addition, the CRRSAA explicitly provides that financial aid grants tot student may be provided to students exclusively enrolled in distance education.

Based on the guidance and criteria provided by the US Department of Education, full or part-time students can apply. This includes those enrolled in academic courses, credit or no-credit bearing courses, dual enrollment courses, or continuing education courses.

Palo Alto College's students apply through the Student Financial Aid Office which then evaluates their eligibility and other applicable CARE Act criteria. An electronic application is being used for students to request funds. On the application, students request funds and also sign a certification stating funds are for expenses as a result of a disruption on their education due to the COVID-19 pandemic. The instructions how to apply are afforded to students through various channels of communication. Once the application is submitted, Financial Aid staff will process applications from the gueue by date received.

How to Apply for Federal Emergency Aid Funds:

- Log into the ACES portal using your Username and Password
- Select the 'Student' option from the sidebar menu
- Select the 'Web Services' link
- Select the 'Financial Aid' tab
- Click on 'Federal Emergency Assistance Application' from the list of options
- This will open a DocuSign page.
- Enter your 'Name' and 'Email' in the required fields and click 'Begin Signing'.
- This will initiate an email to be sent to the address you entered. The email will contain the link to the application.
